# COMMENTARY

## International Arrivals

A significant decline in international arrivals was recorded since restrictions were imposed on International flights by Solomon Island Government towards the end of March 2020, as part of the State of Public Emergency (SOPE) response towards preventing Solomon Island residents and citizens from the COVID-19 pandemic. The SOPE has now been lifted and from July 1, 2022, international flights have slowly resumed.

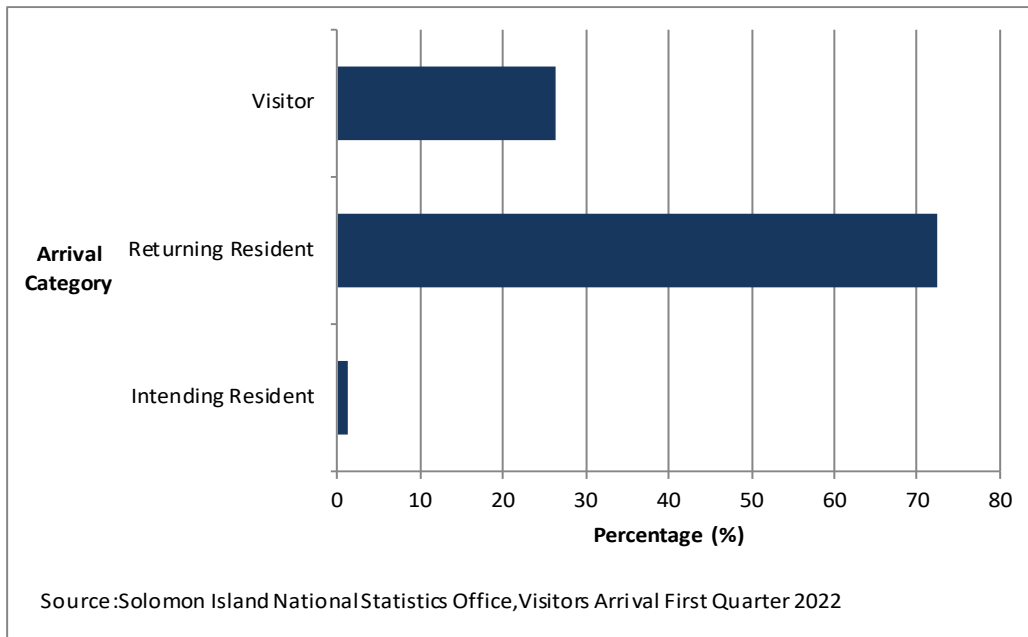
There was 1,044 total arrivals recorded in the first quarter. This is a decrease of 11.1% compared to the previous quarter (4<sup>th</sup> quarter 2021). Compared to the same quarter a year ago, an increase of 28.4% was recorded.

Returning residents made up 72.5% of arrivals for first quarter 2022. This was followed by Visitors with 26.3% of arrivals and the remaining 1.1% were Intending residents.

Visitor arrivals for the first quarter decreased to 275 visitors (34.7%), compared to the fourth quarter 2021 figure of 421 visitors. However, visitor arrivals in the first quarter more than doubled (113.2%) compared to the same quarter in 2021.

Chart 1 shows that the returning category make up the largest proportion of all arrivals while the visitors and intending resident categories make up the lesser share this quarter. This information comes from Table 1: Total Arrivals to the Solomon Islands by Purpose of Travel by Sex: 1<sup>st</sup> Quarter 2017 to 1<sup>st</sup> Quarter 2022.

## Visitors by Country of Residence

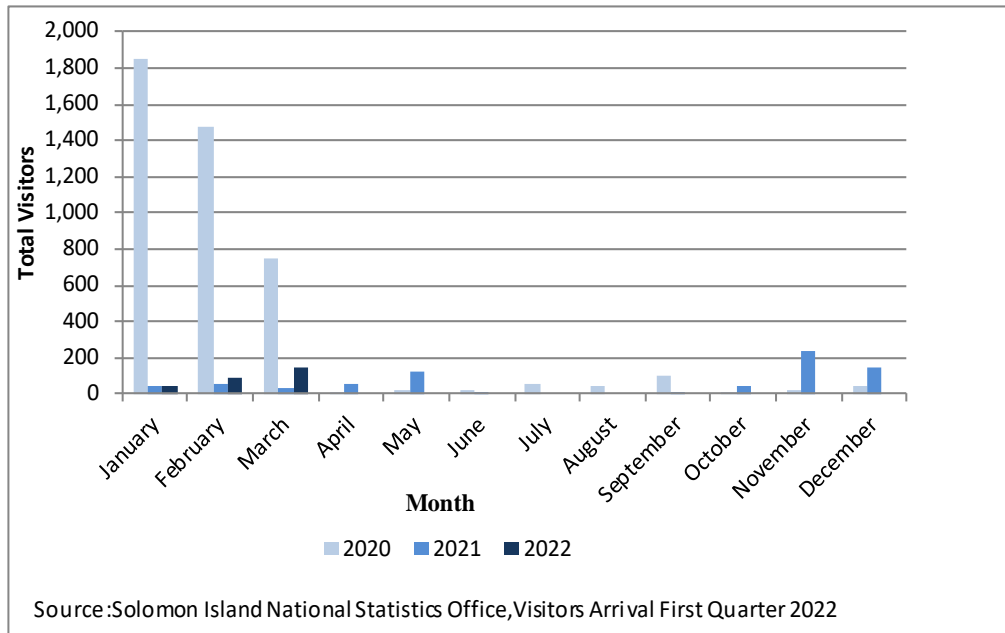
Arrivals by country of residence for the first quarter 2022 showed that Australia (64.0%) recorded the largest group of visitors amongst other country visitors to the Solomon Islands. Although there was 176 Australian visitors in the first quarter 2022, this reflected a decrease of 10.7% compared to the fourth quarter of 2021 figure of 197.

The next largest group of visitors were from Papua New Guinea (11.3%) followed by New Zealand (8.0%), China (4.4), Other Asia (3.6), Other Country (2.2%), United States of America and Japan recording 1.8% respectively, United Kingdom and Other Pacific recording 0.7% respectively, and Fiji, Netherland, France and Italy with 0.4% respectively. Table 2 shows detailed information on Visitor Arrivals to the Solomon Islands by Country of Residence: 1<sup>st</sup> Quarter 2018 to 1<sup>st</sup> Quarter 2022.

## Visitors by Month

Visitor arrivals by month showed that March recorded the highest number of arrivals in the first quarter of 2022 with 143 visitors. This was followed by month of February with a total of 86 visitors and January the least with 46 visitors. This information comes from Table 3: Visitor Arrivals to the Solomon Islands by Month: January 2009 – March 2022.

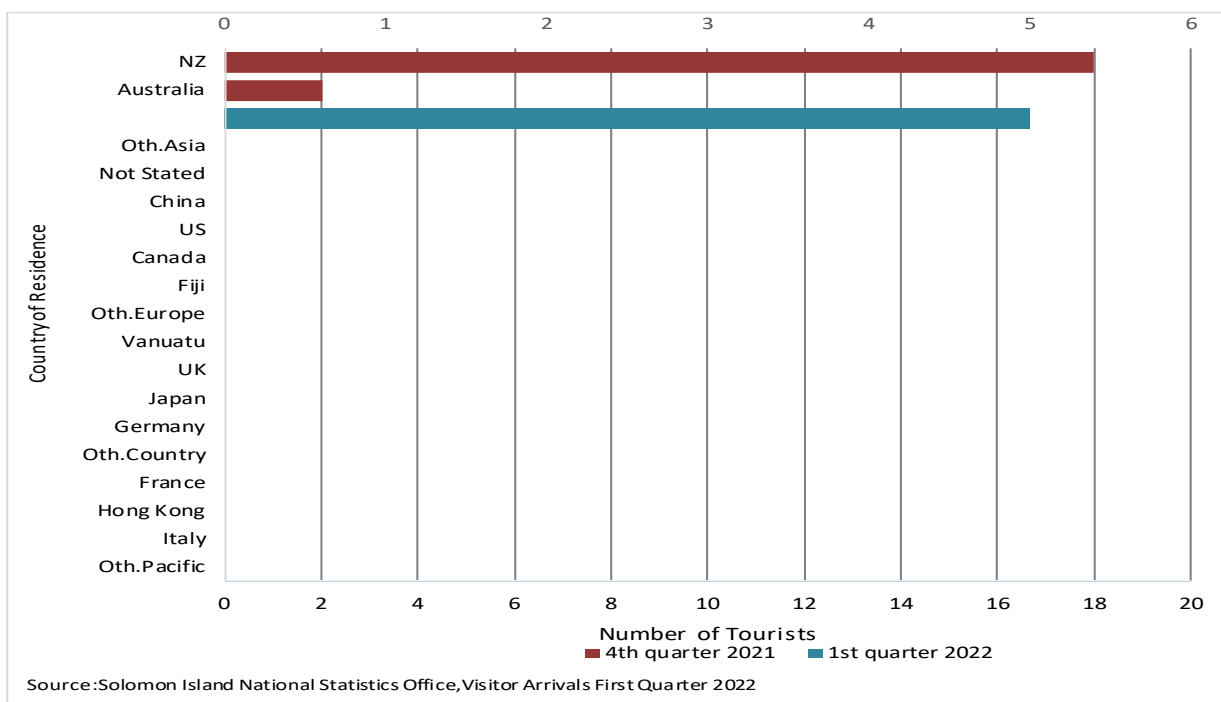
**Chart 2: Visitor Arrivals by Month, January 2020 – March 2022**



## Tourists

Restrictions on international flights as part of the SOPE measure against Covid-19 pandemic had adverse implications on visitors travelling predominately for tourism purposes. This is expected to change after July 1, 2022 with the lifting of the SOPE. First quarter 2022 recorded zero tourists whose specific purpose of travel was for holiday and vacation. However, there were 5 transit-tourists who spent an average of 1.0 days in the country. Australia made up the highest proportion of transit-tourists (100%) for the quarter. 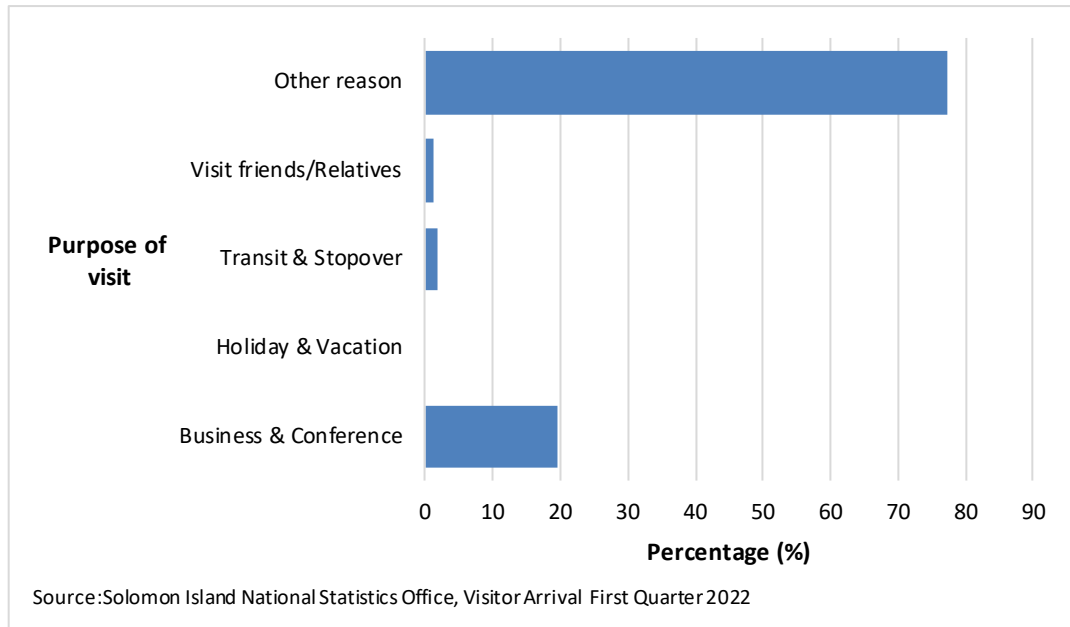
**Chart 3: Tourist by Country of Residence: 4<sup>th</sup> Quarter 2021 – 1<sup>st</sup> Quarter 2022**



### Visitors by Purpose of Visit

The most common reason for visitors visiting the Solomon Islands during the quarter was for Other Reasons (77.5%). This was followed by Business and Conference (19.6%), Transit and Stopover (1.8%) and Visit Friends/Relatives (1.1%). There was no visitor visiting Solomon Islands for Holiday and Vacation during the quarter. ### Visitors by Age Group

The distribution of visitor arrivals by broad age groups for first quarter 2022 showed that 88.0% of visitors were in the 25-64 years age range. The youngest age group, 0-24 years accounted for 3.6% and the oldest age group, 65 years and over represented 2.9% of total visitor arrivals. The remaining 5.5% were visitors who did not state their age. Male visitors represented more than half of the total visitors arrivals (77.5%) and female visitors made up 22.5% of arrivals this quarter. ### Visitors by Occupation

Visitor by Occupation showed that the “Service Worker” category made up the largest percentage of occupations (53.5%) during the quarter. This was followed by “Professional and Technical” (28.3%), “Administration and Managerial”(7.3%), “Student”(3.3%), “No Work and Production and Related Work”(2.2%), Other Occupation”(1.8%), and “Sales Worker and Clerical & Related work” (0.7%). Refer to Table 7: Visitor Arrivals to the Solomon Islands by Country of Residence by Occupation and Sex: 1<sup>st</sup> Quarter 2022. Note that a revision to the occupation classification and tables now include a category for students. This is being incorporated to the Statistical Visitor Arrival Bulletin commencing 1st quarter of 2022 and onwards. Changes are revealed in the presentation of the information on all three categories of arrivals by occupation.

### Visitor by Carrier

The most popular carriers during the quarter were the Unschedule flights that carried (61.1%) of total visitors, followed by the Solomon Airlines (27.6%) and Air Niugini (11.3%).

### Visitor Arrivals to Munda

There was no record of visitors from Brisbane to Munda flights since the closing of International flights at end of March 2020.

## ABOUT THE BULLETIN

### Concepts and Definitions

Persons entering Solomon Islands classify themselves into three (3) categories; returning resident, intending resident, and visitor. The concepts and definitions of the various categories are as follows:

#### (i) Returning residents

- Solomon Islanders and non-Solomon Islanders who have left the country and are returning to continue their residence.
- Non Solomon Islanders includes resident permit holders and Diplomatic officials, and their immediate family members. This also includes persons residing for 12 months or more or under specialized legal or official arrangements.

#### (ii) Intending residents

- Non-Solomon Islander who wish to take up residence in Solomon Islands.

#### (iii) Visitors

- Any traveler who is not a Solomon Islander and their stay and intention of stay should last no more than 12 months<sup>1</sup>, in the country and does not have a permanent/contract employment.
- *Tourist*
  - Visitors who state their purpose of travel as being for ‘*holiday and vacation*’ and ‘*transit*’.
  - Visitors who are transiting (with on-ward final destination) and have stated their purpose of travel as being for ‘*holiday and vacation*’ are treated as transit-tourists, and classified broadly as tourists. This includes limited number of visitors who are simply transiting for other purposes. The latter is subject to review as NSO continues to progressively align its definitions and concepts to meet changing regional and international standards.
  - Spouse/partner accompanying husband/wife/partner on business purpose is treated as a private tourist unless the person is also engaged in a similar or related work-activity remunerated within the place visited.
  - In line with World Tourism Organization WTO definition of Tourism: It comprises the activities of persons travelling to and staying in places outside their usual environment for not more than one consecutive year where pleasure is being the predominant motivation.

#### (iv) Markets

- Country of Usual Residence is referred to as ‘markets’ by the Solomon Islands Visitors Bureau.

*Note: There may be some variations in the total number of visitor arrivals reported by the National Disaster Office/Ministry of Health under the government’s State of Public Emergency response on COVID-19 pandemic and the NSO. However, the NSO will continue to adhere to its data collection process and dissemination of the results.*

*Note 1: For Quarter 1, 2018 onwards the National Statistics Office will be using the new set of definitions provided by the South Pacific Tourism Organization (SPTO).*

*Note2: The National Statistics Office is reviewing the occupation classification and have included “Students” as a independent category on table 7, 9 and 12 commencing quarter 1,2022 onwards.*
